If possible, please include a computer disk (Word .doc, or .txt or .rtf formats), or e-mail to the editor as an attached file. Manuscripts longer than 15 typed pages (about 4500 words) may be shortened when edited. Use the current A.O.U. Check-List for bird names and sequence. Provide tables and figures on separate pages. Black-and-white photographs and graphics are best. Include author's or artist's name, address, and telephone number and information from which a brief biography can be prepared. Scientific and technical articles are peer reviewed.
