

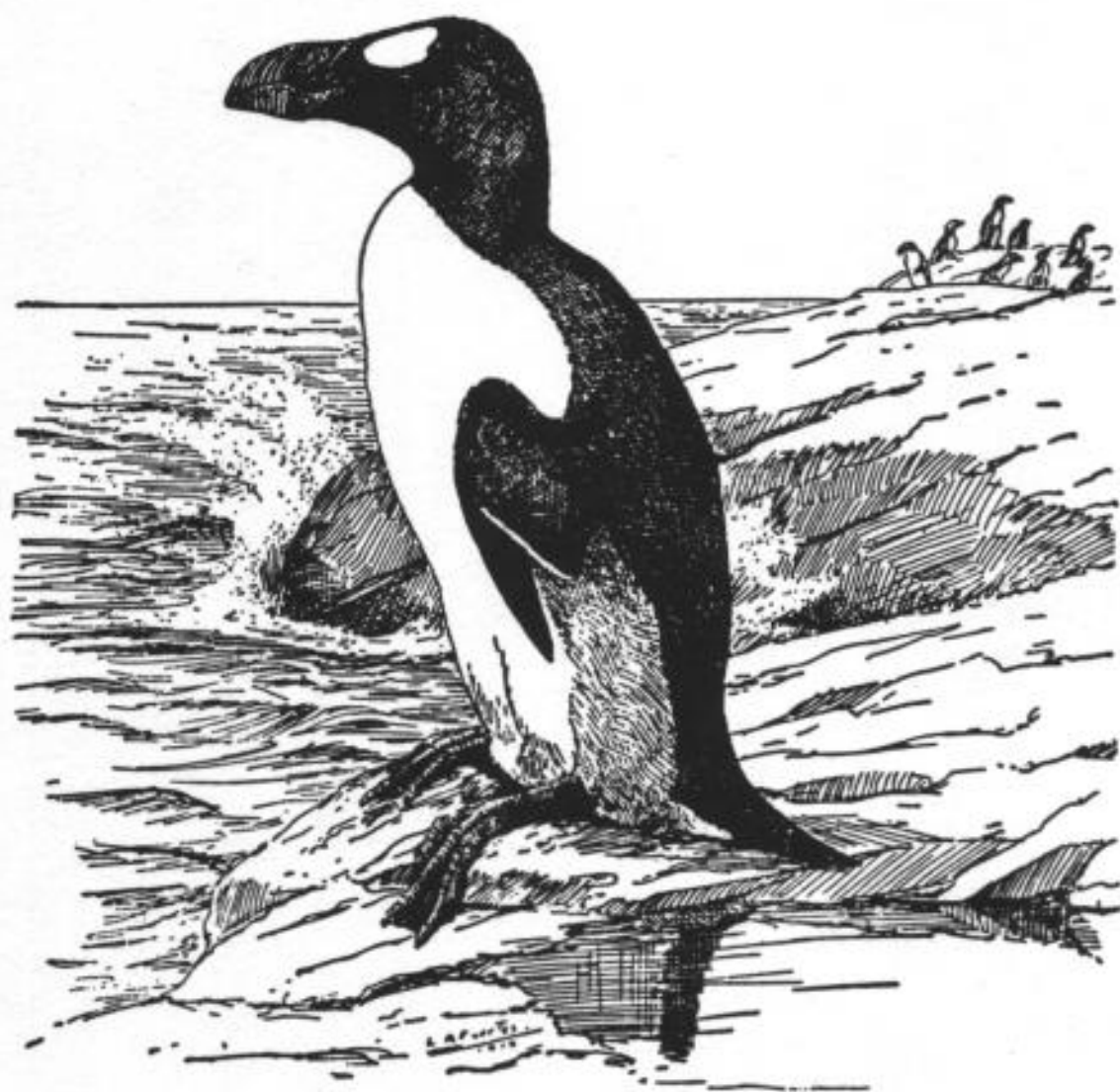

A Life Membership is \$360, which may be paid in one lump sum or in installments of \$90.00 per year over a four-year period. Any person may become a Patron on a gift or bequest of \$1000, or a Benefactor on a gift or bequest of \$10,000, into the General Endowment Fund or such other fund as may be approved by the Council. The name of each Patron and Benefactor is inscribed in perpetuity in the records.
