The Standing Committee for Ornithological Nomenclature of the International Ornithological Congress has been appointed as follows: J. Dorst, Muséum National d'Histoire Naturelle, Paris; E. Eisenmann, the American Museum of Natural History, New York; F. Salomonsen, Universitetets Zoologiske Museum, Copenhagen; K. H. Voous, Zoologisch Museum, Amsterdam; and C. Vaurie (chairman), the American Museum of Natural History, New York.

This committee is purely advisory, but ornithologists who wish to make a proposal for action to the International Commission for Zoological Nomenclature may submit, if they wish, such proposals to the Standing Committee for its consideration. This Committee may, at its discretion, inform the International Commission of its opinion. The Standing Committee endorses the principle of the Preamble of the Code of Zoological Nomenclature that well-established names should be preserved. Proposals for this committee should be sent to the chairman in quintuplicate.

The Louis Agassiz Fuertes Research Grant, established in 1947, is devoted to the encouragement and stimulation of young ornithologists. One particular desire is the development of research interests among amateur ornithologists. Any kind of ornithological research may be aided. Recipients of grants need not be associated with academic organizations. Each proposal is considered primarily on the basis of possible contributions to ornithological knowledge.

An anonymous donor gave \$500 to found the fund; later donors have provided some \$600. The Council of the Wilson Ornithological Society has added funds as necessary to provide at least one \$100 grant annually.

Since its inception, the Fuertes Research Grant has been awarded to 19 persons, many of whom have continued their research work.

Application forms may be obtained from Harvey I. Fisher, Southern Illinois University, Carbondale, Illinois. Completed applications must be received by March 1, 1964.

The next closing date for research proposals to the National Science Foundation is January 15, 1964. Action on proposals will be reported no later than four months after that date.

In the past year the editors of The Condor have had the assistance of a number of persons in appraising manuscripts offered to the journal.
