# INTERNATIONAL COMMISSION ON ZOOLOGICAL NOMENCLATURE

An announcement of the possible use by the International Commission of its plenary powers includes the following avian cases:

1980. Rejection of all usages of THRAUPIDAE,

prior to that of Wetmore & Miller.

2074. Suppression of *Plyctolophus ducrops* Bonaparte, 1850. Comments should be sent in duplicate, citing case number, to the Secretary, International Commission on Zoological Nomenclature, c/o British Museum (Natural History), Cromwell Road, London SW7 5BD, England.

### SHOREBIRD COLOR-MARKING

In 1975, the Canadian Wildlife Service plans to carry out extensive banding and color-marking of shorebirds in James Bay and the Maritime Provinces in eastern Canada. Colored leg bands and feather dyes will be used to mark the birds. Observers throughout eastern North America are asked to look out for any such birds and to record details of: species, place, date, details of color-marks or bands-for colored and standard metal leg bands, record which leg the bands were on, the colors involved, and the relative position of the bands if more than one was on a leg (e.g. right leg, red above blue, etc.). For color-dyed birds, record the color and area of the bird that was dyed. Details should be sent to Dr. R. I. G. ## INTERNATIONAL SHOREBIRD SURVEYS

In 1974, shorebird survey schemes were initiated in the Maritime Provinces of eastern Canada and in areas of the eastern U.S. and have provided valuable information concerning shorebird migration and for identifying and documenting areas of major importance. In 1975 it is planned to extend this scheme to as many areas as possible including eastern Canada and the U.S.A., the Caribbean Islands and northern South America. Observers who might be able to participate in regular census surveys during spring and autumn migration periods, as well as in areas where wintering populations of shorebirds are found are asked to contact one of the following:

#### **ERRATUM**

Anita L. Parker recently reported an observation of a Black-headed Grosbeak (*Pheucticus melanocephalus*) at Atlanta, Georgia, stating that to her knowledge this was the first sighting of the species in Georgia (Condor 76:350). While her note was in proof, she informed the editor that she had found an earlier record (Oriole 32:34), but owing to an oversight this was not added to her article. The editor was subsequently informed of additional records (Oriole 28:26, 38:24), making it clear that Parker's observation was hardly the first for the state. He is chagrined further to discover that this article is a verbatim repeat of the same article that appeared earlier in the Oriole (38:29). *The Condor* does not knowingly publish articles that have been published elsewhere.

## SELECTED RECENT PUBLICATIONS

Birds of Western North America.—Paintings by Kenneth L. Carlson, Text by Laurence C. Binford. 1974. Macmillan Publishing Co., Inc., New York. 223 p. \$25.00. This is a book of full-page ( $24 \times 32$ cm) color plates and accompanying text for fifty selected species of nonpasserines. Many of the birds are shown in characteristic postures amidst a hint of their typical habitat. To the reviewer's eye, most of the plates are pleasing and some, such as the Western Grebes, Prairie Falcon, Sage Grouse, Long-billed Curlew, and the owls are excellent. In others, however, perspective has not been handled properly, producing misshapen or awkward figures, as in the Storm-petrel, Black Oystercatcher, and the Marbled Murrelet. The color printing is generally good but several plates appear too reddish overall and/or lacking richness in the blacks. The only mistake noted is in the caption for the Broad-billed Hummingbird; the picture shows the male gathering spiderweb for the nest, not the female, as stated.

The text is stronger than the plates, unlike most books of this kind. In his Introduction, Binford has done a good job of explaining birding to the uninitiated, and encouraging experienced birders to take up more technical studies. His essays for the individual species present a lot of information in a well-written manner. Many of the same topics (size, range, habitat, diet, nest, etc.) are treated in every account, yet the essays do not follow a standard pattern. Each is different. Species are not merely described but are also used to illustrate scientific

principles or point out gaps in our knowledge. This is far above the customary writing of coffee-table bird books.

Population Ecology of the Mallard. II. Breeding Habitat Conditions, Size of the Breeding Populations, and Production Indices.—Richard S. Pospahala, David R. Anderson, and Charles J. Henny. 1974. Bureau of Sport Fisheries and Wildlife Resource Publication 115. U.S. Dept. Interior, Washington, D.C. 73 p. \$1.60. Stock No. 2410-00387. This report evaluates data collected during May and July, 1955–73 in Alaska, Canada, and the north-central U.S. Analysis brings out the possible key factors that regulate the total Mallard population in North America.

Population Ecology of the Mallard. III. Bibliography of Published Research and Management Findings.—David R. Anderson, Patricia Ann Skaptason, Kathleen G. Fahey, and Charles J. Henny. 1974. Bureau of Sport Fisheries and Wildlife Resource Publication 119. U.S. Dept. of Interior, Washington, D.C. 46 p. \$1.30. Stock No. 2410-00377. This is a limited, classified list of 935 references pertaining primarily to the management of the Mallard. This publication and the preceding are available from the Superintendent of Documents, U.S. Govt. Printing Office, Washington, D.C. 20402.

Ocean Wanderers/The Migratory Sea Birds of the World.—R. M. Lockley. 1974. David & Charles, Newton Abbot, Devon, Great Britain; Stackpole Books, Harrisburg, Pa. 168 p. \$15.00. This book covers much the same subject as Sea-Birds, which Lockley wrote with James Fisher (1954, Houghton Mifflin Co., Boston), but it is a wholly new work. It is not only updated but also aimed at more general readership. Expertly written chapters deal with the evolution and adaptations of sea birds, behavior, ocean feeding grounds, navigation, effects of mankind, and the birds themselves. The book is well illustrated with drawings by Robert Gillmor, 37 photographs, and 22 maps.

Volume 108, Section 18. Zoological Society of London. 264 p. £ 11.00. The indexes of this annual have been refined, making it more useful than ever as a guide to the scientific literature. Approximately 3500 publications are listed for 1971, the latest year covered. In spite of the time lag, research-minded ornithologists may find it worth the cost (\$26.84) to have a copy close at hand.

Autumn Hawk Flights/The Migrations in Eastern North America.—Donald S. Heintzelman. 1975. Rutgers Univ. Press, New Brunswick, N.J. 398 p. \$30.00. The southward migration of hawks along the mountain ridges of eastern North America is at times spectacular. This book is the first full synthesis of the voluminous data on this phenomenon. Novice hawkwatchers should read the parts on field study methods, hawk identification, and the hawk lookouts (a useful catalog). More advanced birders can learn from the chapters on raptor morphology and flight, on hawk migrations and weather conditions, on migration routes, geography, and hawk counts, and on the evolution of the Broad-winged Hawk. The book is written in a nontechnical style and contains abundant data, including 60 tables. It is illustrated with many photographs (which suffer in reproduction), maps, diagrams, and graphs.

Avian Energetics.—Edited by Raymond A. Paynter, Jr. 1974. Publications of the Nuttall Ornithological Club, No. 15. Cambridge, Mass. 334 p. Available from the Nuttall Ornithological Club, c/o Museum of Comparative Zoology, Harvard University, Cambridge, Mass. 02138. This important book is the record of a symposium arranged by the Nuttall Club to mark its Centennial in 1973. The four papers are "Seasonal allocation of time and energy resources in birds" by James R. King, "Consequences of body size for avian energetics" by William A. Calder, III, "Energetics of reproduction in birds" by Robert E. Ricklefs, and "Energetics of natural avian flight" by Vance A. Tucker. Each is a masterful review of its subject, written for advanced workers. The discussions that followed the papers are included. The Nuttall Club deserves to be commended for sponsoring this symposium and for producing this wellmade book.
