1983 MEETING OF THE C.O.S.

The 53rd Annual Meeting of The Cooper Ornithological Society will be held on the campus of The University of New Mexico in Albuquerque, New Mexico from Thursday, 19 May, through Saturday, 21 May, with field trips on Sunday, 22 May. INFORMATION ON DISABLED SCIENTISTS

The AAAS Project on the Handicapped in Science is updating its Resource Directory of Handicapped Scientists. The Directory, first published by the American Association for the Advancement of Science (AAAS) in 1978, includes a listing of disabled scientists, engineers, and science students throughout the United States. Information provided in the Directory is useful to school administrators and educators in identifying handicapped scientists to use as advisers, counsellors, and role models. The listings can be used as a resource for those assembling advisory bodies and peer review panels. The Directory can be valuable to scientists who become physically disabled midcareer and wish to learn strategies others have developed for coping with disability. It demonstrates, to both disabled and able-bodied persons, the wealth of experience and the range of specialties represented by disabled scientists.
