## AMENDED BYLAWS OF THE COOPER ORNITHOLOGICAL SOCIETY

Present wording:

#### IV. Officers

#### (3) Election.

- (c) In subsequent years, one of the following procedures shall be used. (i) If the President's term does not expire at said meeting, the President shall dissolve the old Board, seat the new Board, including the newly elected Directors, and immediately conduct the elections of the chief Editors (if necessary), and the remaining Officers, except a President-Elect.
- (ii) If the President's term expires at said meeting, the President shall dissolve the old Board and appoint one of the existing Directors to preside over the meeting. Said Director shall seat the new Board, including the newly elected Directors, and immediately call for confirmation of the President-Elect as President. If confirmed, the new President shall immediately take office and then conduct the elections of the chief Editors (if necessary) and the remaining Officers, including a President-Elect.

#### IV

(4) Term. Each Officer shall take office immediately upon election and shall serve the appointed term or until a successor is elected and qualified. The President and President-Elect shall each be elected for two-year terms; other Officers shall be elected for one-year terms. Officers may serve successive terms.

#### III. BOARD OF DIRECTORS

(4) Term. Each Director shall take office when officially qualified during the second session of the regular Board meeting immediately following the Regular Business Meeting at which elected and shall hold office for a three-year term.

#### New wording:

- (c) In subsequent years, one of the following procedures shall be used. (i) If the President's term does not expire at said meeting, the President shall announce the dissolution of the old Board and the seating of the new Board, including the newly elected Directors. The President will conduct elections of the chief Editors (if necessary), and the remaining Officers, except a President-Elect.
- (ii) If the President's term expires at said meeting, the President shall announce the dissolution of the old Board and the seating of the new Board, including the newly elected Directors, and call for confirmation of the President-Elect as President. If the President-Elect is not confirmed, or is unwilling to serve as President, the Board will nominate a slate of candidates and elect a President, as specified in Section IV(3) (a). The President will conduct elections of the chief Editors (if necessary) and the remaining Officers, including a President-Elect.
- (4) Term. Each Officer shall take office immediately upon adjournment of the final session of the regular Board meeting following the Regular Business Meeting of the Society. The President and President-Elect shall each serve two-year terms; other Officers shall be elected for one-year terms. Officers may serve successive terms.
- (4) Term. Each Director shall take office for a threeyear term immediately upon adjournment of the final session of the regular Board meeting following the Regular Business Meeting at which elected.

One Man's Owl invites the reader to share in the experience of watching a great horned owl that Bernd Heinrich adopted during a late spring snow when it was too young to fly or survive by itself. Combining reflections on natural history with a journal of the owl's development, the book is an engaging chronicle of how the author and "Bubo" came to know one another over three summers spent in the Maine woods, and how Bubo eventually grew into an independent hunter.

Heinrich watched Bubo with open-ended questions in mind, particularly in relation to the hunting skill of owls and the ''mobbing'' of the owl by other birds. While not intended as a scientific treatise, this work includes the author's speculations on why mobbing birds remain unscathed by the owl, which is primarily a stealth predator and which does not seem interested in attacking birds that are aware of its presence.

One Man's Owl, including the author's own drawings and photographs, is a compelling journal of field research and personal observations that makes a strong case for the conservation of our natural resources.
