

WHO HAS THESE BANDS?

The Fish and Wildlife Service has requested the coopération of bird banders in locating a considerable number of bands that do not appear in the Service's issue index.

The quantity and numbers of the missing bands are:

100 bands size 2.	39-247001 to 39-247100
200 bands size 3.	40-321701 to 40-321900
10,000 bands size 6.	B677001 to B687000

Since recovery records from some of the above series have been received, the Service is especially anxious to locate the station operators to whom they were issued.

Please examine your bands and records, and if you find that you have or have had any of the bands numbered in the groups listed, please notify the Service so that their records may be corrected.
