NOTES AND NEWS

The prices for separates shown in *Bird-Banding*, 34: 177, July, 1963, are still in force. However, as the printer found he had underpriced the charge for extra copies of the entire issue, the cost of such copies (when ordered by authors, before the issue is printed) is now 40c each, including postage. Whole copies may be cheaper for an author if he wants only a few, or for extremely long papers.

Prices for the nine types of mistnets regularly stocked by NEBBA are as shown in the January, 1966 issue, though parcel post insurance rates have gone up meanwhile, and an increase in basic parcel post rates appears imminent. As this issue goes to press, we have received a few of the new tethered nets (type HT), discussed in the April issue, but have not yet heard how these are performing in the field.
